- Understand that Five Dock Leisure Centre has a zero tolerance policy on any behaviour deemed to be excessively aggressive or anti-social
- Respect the decisions of the coaches and referees and teach the children to do the same thing.
- Support, encourage and help volunteers, coaches, organisers and officials in their work. Without them, the children would not have the opportunity to play futsal.
- Be a good sport and applaud all good plays whether they are made by my team or the opposition
- Ensure my decisions and actions contribute to a safe environment
- Will not arrive at the Five Dock Leisure Centre under the influence of drugs or alcohol
- Respect the rights, dignity and worth of all participants regardless of their gender, ability, cultural background or religion
- Thank the opposition and officials at the end of the game
